

Structure of VAT ID within European Union member states

This sample demonstrates the table header and table footer capabilities.

As you can see, the column headings are displayed on every page the table appears. You can achieve this behaviour by writing the corresponding code within the **thead** element, e.g.:

```

The same procedure applies for defining the **tfoot** element:

  ...
  <tfoot>
    <tr>
      <td colspan="5">Please make sure that your company's VAT ID is stated on all invoices,
      quotations and delivery notes!</td>
    </tr>
  </tfoot>
</table>
```

Thus the required heading and footer information can be printed on every page containing the table.
